Position Overview

The Program Coordinator will work across two San Francisco Department of Public Health workforce development programs run by Springboard Health Lab, The Academy and the Community Health Leadership Initiative (CHLI), centering people with lived experience and community health workers new to the field.

The Community Health Leadership Initiative (CHLI) aims to develop and sustain a highly skilled sexual and drug user health workforce, cross-trained in HIV, HCV, and STIs, that reflects the populations served, has low turnover rates, and is valued and supported.

The Academy is a training program that provides free health education offered in Spanish and English and is designed for people with lived experience who are entering the workforce and for community health workers. The Academy training program focuses on sexual health and drug user health curriculum, with a major focus on health equity. The Academy partners with SFDPH Learning Management System (LearnSFDPH) and supports developing and curating high-quality training for the LearnSFDPH website.

The coordinator will support the Academy Program Manager and Director of Community Health Leadership Initiative Workforce Development Programs in the day-to-day operations of the programs. The coordinator will be responsible for the communications and general workforce development support for program participants with lived experience who want to enter the field. The Coordinator will support the creation of a monthly newsletter that centralizes the communication of workforce development efforts and training, and will also coordinate events for folks interested in entering the field. The Program Coordinator will also partner with the CHLI Director to oversee the logistics and planning of the CHLI Training and Mentorship Program, a 12-week sexual and drug user health workforce development pathway program.

The Program Coordinator will work closely with the Academy Program Manager and the Community Health Leadership (CHLI) Director and will report to the CHLI Director.

• Manage prompt and effective communication with people with lived experience who are interested in entering the workforce by navigating them to workforce development programs, training and opportunities that supports their needs

• Oversee events for the community of people who have been through the CHLI Training and Mentorship Program to provide post-program support, navigation, linkage to opportunities and host regular networking opportunities

• Attend regular team meetings with the CHLI/ Academy Team to discuss plans and progress

• Create relationships with providers in the workforce development sector to support the creation of a monthly newsletter to coordinate communications about The Academy training, LearnSFDPH, and partner training and workforce development programs

- Support the evaluation component of both programs
- Exercise sound judgment in navigating multi-stakeholder partnerships, reconciling competing priorities, and managing difficult conversations
- Apply health equity principles and an antiracist lens
- Maintain positive working relationships and effective communications with the funder (SFDPH) and other stakeholders

• Work closely with the CHLI Director, CHLI Team and Academy Program Manager to complete tasks as assigned and support the implementation of other new projects as opportunities arise
